Treasurer's Report: III.

Due to unforeseen circumstances and received information regarding our management company's involvement in legal proceedings with another association, the Board of Directors discussed what would be best for the Stratford Green Condominium Association. After the lengthy discussions at the executive session, the Board felt that the board's fiduciary duty is to protect the association and take any necessary precautions in the current situation. All Board members unanimously agreed that it was in the Association's best interest to cancel the contract with the current management company, Silaba LLC, dba US House Realty / LBN Property Management LLC.

From the contract:

Termination by either party

(a) either party shall have the right to terminate this Agreement, with or without cause, upon sixty (60) days written notice to the party, provided the notice is given at the end of the month so that termination is not mid-month.

The Board felt canceling the contract immediately would be in the Association's best/safe interest. Therefore, the Board agreed to follow the agreed-upon terms and pay the Management Company, LBN Property Management, LLC., the amount equal to two months' pay per the agreed-upon terms.

- -Pavlina Pacasova made a motion, Sean Oja seconded, and all board members agreed and voted to cancel the contract.
- -Sean Oja made a motion to discontinue the Tressler LLP legal retainer going forward, Mark Nelson seconded, and all board members voted in favor.
- -Mark Nelson made a motion, and Sean Oja seconded, to retain Saul Ewing LLP as the new association's legal counsel. All board members voted in favor.
- -All board members agreed that Mark Nelson, **not** Daiva Majauskas, is the new counsel's direct contact/liaison.
